

Volunteer Agreement and Waiver

ALL VOLUNTEERS ARE REQUESTED TO READ AND SIGN THIS DOCUMENT

Waiver, Release and Indemnification

For and in consideration of the opportunity to serve as a volunteer for the **Good News Home, Inc.**, also known as the Good News Home for Women, the undersigned hereby voluntarily releases, discharges, waives and relinquishes any and all actions or causes of action for the personal injury, property damage or wrongful death occurring to it arising as a result of the activities or services which the undersigned may engage in through the volunteer opportunities offered by the Good News Home, or any activities incidental thereto, wherever or however the same may occur and for whatever period said activities or services may continue, and from time to time, and the undersigned does for himself or herself, his or her heirs, agents, executors, administrators and assigns hereby release, waive, discharge and relinquish any action or causes of action, aforesaid, which may hereafter arise for it, and agrees that under no circumstances will the undersigned or her or his heirs, agents, executors, administrators present any claim for personal injury, property damage or wrongful death against the Good News Home, or any of their officers, agents, servants, or employees for any of said persons, or otherwise. **IT IS THE INTENTION OF THE UNDERSIGNED BY THIS INSTRUMENT TO EXEMPT AND RELIEVE THE GOOD NEWS HOME FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH.**

The undersigned, for herself or himself, her or his heirs, agents, executors, administrators agrees that in the event that any claim for personal injury, property damage or wrongful death shall be prosecuted against the Good News Home, the undersigned shall indemnify and save harmless the same from any and all claims or causes of action by whomever or wherever made or presented for personal injuries, property damage or wrongful death.

Confidentiality Statement

During service as a volunteer the undersigned may learn things about, or names of, the clients (women residents in treatment) of the Good News Home or their friends or family. The privacy of our clients must be protected at all times. No information about any client or visitor utilizing any service of the Good News Home shall be shared with others either during or after the time of volunteer service. Any information about our clients, even the fact that they are at the Good News Home receiving treatment, is highly confidential. Never reveal information of any sort about one client to another client or visitor. It is mandatory for volunteers to maintain the privacy and confidentiality of all clients in order to foster a position of trust and to protect our clients' legal rights. Violation of this confidentiality statement can result in immediate termination of your service and could result in the initiation of legal action.

Other Declarations

I agree and consent to the use of my voice, image and/or name by the Good News Home for any broadcasting, print or audiovisual purposes in connection with an event or other activities, without limitation as to place, time or medium. I grant permission to the Good News Home to make editorial changes desirable for production purposes. This I do without claim to remuneration or charges either immediate or future.

The undersigned acknowledges that she or he has read and understands the foregoing, and hereby agrees to the declarations, and terms and conditions of this instrument by her or his own free will.
